## Authors Urge Govt to Stop APBS Push

A study that analysed 31 million transactions for MGNREGS payments spread across to states found that there was no significant difference between Aadhaar-based and account-based payments. Based on the study, the authors have urged the government to stop the push for Aadhaar Payment Bridge System (APBS).

Bengaluru: Much-awaited pictures of India's Vikram with its legs planted firmly on the lunar surface, as seen by the rover Pragyan's eyes, have reached Earth. They show the Chandrayaan-2 lander with the ramp, which allowed rover Pragyan to roll out of the lander after the Moon landing on August 23. The visuals also show two payloads — Instrument for Lunar Seismic Activity (ILSA) and Chandra's Surface Thermo Physical Experiment (ChSTE) — descending from Vikram onto the Moon's surface in situ experiments.
